1. **Purpose.** Define the quarterly training goal and the plan to meet this goal.

2. **Cancellation.** QTP for Third Quarter, FY00.

3. **Quarterly Training Goal.** By 30 September, the battalion will complete all individual Marine Corps annual training requirements for FY 00, while supporting the regiment with duty battalion obligations.

a. Battalion METL. See Ref (a). A single task, Task 5. Conduct Helicopterborne Operations, will drive training for battalion leaders.

b. Echelon of training. Individual training has priority.
